INSTITUTION SPECIFIC SPOT ADMISSION POLICY FOR APPLICANTS

- Applicants who have already registered and duly filled-up their form in the Samarth Portal and those who have registered and filled-up their forms on or before 10:00 AM on the date of admission as mentioned above are eligible for Spot Admission.
- **Admission will be held purely on the basis of merit and subject to the availability of vacancies.**
- Applicants must be present at the time of announcement of a particular percentage / category during Spot Admission. Those who are absent at the time of such announcement shall forfeit their claim for admission and will not be entitled to make any claim thereafter.
- CBSE / Other Board students who do not possess their original Marksheet must compulsorily show their document in Digilocker.

- Original and xerox copy of Caste Certificate (if applicable). Admission under reserve category will be governed by the guidelines of the Government of Assam.
- Candidates availing Free Admission must compulsorily produce their Ration Card / original Income Certificate issued by the Circle Officer along with xerox copies of Pan Card and Aadhar Card of the person in whose name the Ration Card/Income Certificate has been issued.

- **Candidates applying under EWS category must compulsorily produce their original Income and Asset Certificate in prescribed Government format issued by the Circle Officer.**
- **Candidates claiming admission under OBC category must compulsorily produce their Caste Certificate as well as the Non-Creamy Layer Certificate / NCL Acknowledgement Receipt at the time of admission.**
- **Candidates claiming admission under SC, ST (Hills & Plains) category MUST compulsorily produce their Caste Certificate at the time of admission.**
- **Gap Certificate in the form of Court Affidavit (if applicable) should be produced at the time of admission.**
