1. The project work will carry 20 marks which consist of 15 marks for preparation of the project report and 5 marks for viva-voce.
2. Last date of submission of the report will be informed later on.
3. Project work must be submitted by the student in a spiral binding form
4. Students must write the report in their own hand writing in A4 sized paper using **blue pen** in single side only.
5. Cover page of the project should contain the following :
  - Title of the project
  - Name, Council's Roll No. Class Roll No., Registration No., Year of Regd.
  - Name of the Supervisor/Guide
  - Name of the College
  - Year
6. **The main body of the Project will consist in the following orders.**
  - Acknowledgement
  - Declaration by the student
  - Certificate from the guide/supervisor (to be collected from respective guide)
  - Certificate from the Head of the institution (to be collected from the head of the department, Accountancy)
  - Contents (details of all the following 4 chapters along with page numbers)
  - Main text of the Project
  - References/Bibliography (name of text book, reference book, any publications used to be mentioned here)
